TERMS & CONDITIONS

Agreements

BY RECEIVING THESE TERMS AND CONDITIONS AND SUBMITTING PAYMENT, THE CLIENT AGREES TO ABIDE BY THE FOLLOWING:

1. Parties

In these Terms and Conditions, the following words and phrases shall bear the following meanings:

"Stylist" and "Tie The Knot In Style" refers to any stylist working on behalf of Tie The Knot In Style.

"Client" refers to the individual to receive any service to be provided by Tie The Knot In Style.

2. Creative Credit

Unless stated otherwise, all images included in the Style Guide are from third-party designers and retailers. Tie The Knot In Style does not claim to be the owner or original creator of any linked item. All images featured within this Style Guide are linked to the original retailer in order to provide appropriate creative credit.

3. Service Assurances

Upon payment, the stylist will schedule a consultation. After the consultation, the stylist will create a Style Guide complete with 5 looks including clothing, accessories, shoes, and handbag/purse. Up to 2 of the provided looks will be recreated at no additional charge. The cost of clothing, accessories, shoes, and handbags are independent of the Styling Fee and are paid by the client. Links will be provided for the client to purchase items from each look. Tie The Knot In Style assures that stylists will provide the services with reasonable skill and care.

4. Affiliate Links & Partnerships

Tie The Knot In Style is affiliated with rewardStyle and utilizes affiliate links when available. This means that commission from the use of an affiliate link will be provided directly to Tie The Knot In Style. Style Guides are created with pieces from preferred designers and retailers, not based on the availability of affiliate links. The client is not required to purchase items through the provided affiliate link, though this is preferred. Any items included in a Style Guide that is part of a partnership between Tie The Knot In Style and a brand, designer, or retailer will be disclosed.

4. Payment

Payment is due prior to initial consultation and creation of each personalized Style Guide. The Stylist Fee is payable in advance and is non-refundable under any circumstances. Payment is made through PayPal or Venmo.

5. Limitation of Liability

The stylist assumes no liability due to the quality of items received from third party designers, brands, or retailers. Tie The Knot In Style makes all reasonable efforts to ensure recommendations are made through the use of looks curated from reputable sources.

6. Cancellations and Refunds

If the service is cancelled on behalf of the client, any advance payment will not be refunded. In the event a cancellation is made on behalf of Tie The Knot In Style stylist, payment will be refunded in full.

Neither party will disclose any information of the other which comes into its possession under or in relation to this Agreement and which is of a confidential nature.
